

## Valley Water Mill Lake

### Angler Frequently Asked Questions

1. What is in the lake? Largemouth bass, bluegill and channel catfish are the main species in the lake. From time to time an angler may catch a crappie, or see a koi (colorful carp)
2. Do you need a fishing license? Yes, everyone who fishes at Valley Water Mill Lake must have the appropriate lifetime, annual, or daily fishing permit or qualify for an exemption. These can be purchased over the counter from any permit vendor or online at [www.mdc.mo.gov/permits](http://www.mdc.mo.gov/permits). A list of exemptions can be found in Chapter 5 of the Wildlife Code of Missouri. A copy of the Wildlife Code Book can be picked up where ever permits are sold.
3. How many fish can I take?

#### Valley Water Mill Lake Fishing Regulations:

<u>Species</u>	<u>Daily Limit</u>	<u>Length Limit</u>
Black Bass	6 daily	12 to 15 inch protected slot
Crappie	30 daily	
Catfish (all catfish species)	4 daily	
All others	10 daily	

4. Other regulations?
  - No boats allowed
  - Pole and Line Only (no jug lines, trot lines or limb lines)
  - Maximum 3 poles per person
5. What is a 12 to 15-inch protected slot? Basically, anglers need to immediately release any black bass (i.e. largemouth bass) that are between 12.0 inches and 15.0 inches. They can harvest black bass below 12 inches and above 15 inches.
6. What are the hours for the park? The park facilities will be open from sunrise to sunset. Springfield-Greene County Park Board is in charge of opening and closing the facility on a daily basis.

7. Can you fish at night? No, the park is closed between sunset and sunrise.
8. Public restrooms? The restrooms at the park will be available only during the regular business hours of the Watershed Center during the spring, summer and fall months. All restroom facilities will be closed during the winter, except those at the C.W. Titus Education Facility.
9. Swimming? No, this lake is owned by City Utilities and is part of the Springfield's water supply system.
