### **Storm Water Task Force**

Last fall a 30 member citizen taskforce was formed by Springfield's City Council and the Greene County Commission, with the goal of studying the long term needs of the City and County stormwater programs which includes ongoing costs for flooding issues, infrastructure needs and clean water mandates. On September 6<sup>th</sup> at the WCO monthly meeting, Todd Wagner, Principal Stormwater Engineer for the City of Springfield will be presenting on the Stormwater Management Task Force recommendations. ## **Big Urbie Update**

Campbell Streetscape Project: If you have driven north on Campbell Avenue through downtown recently, you likely noticed a major change in the road design. Through the Big Urbie grant, rain gardens and "tree box filters" were constructed at part of the street project. The design is more aesthetic, and functional. Three rain gardens are numerous tree box filters are designed to reduce urban runoff (which travels to Jordan Creek) by allowing stormwater to slow down and soak into the ground. Additionally, trees are effective "solar dewatering pumps" as engineers put it. The native vegetation will be planted this fall, so stay tuned for more pictures!



**FREE Soil Tests:** Proper lawn fertilization is critical to clean water in the Ozarks. Getting a soil test can **save money** on fertilizer by meeting your lawn's exact nutrient needs. Excess fertilizer commonly runs into rivers and streams. The Watershed Committee of the Ozarks in partnership with the James River Basin Partnership is offering a **FREE soil test** and nutrient management plan for yards in the South Creek, Jordan Creek, Fassnight Creek and Pea Ridge Creek Watersheds. One of the highlights of the year has been the Ozark Summer Watershed Academy. The purpose of the academy was to provide participants with an in depth and hands-on educational experience focusing on local

water resources. The speakers were fantastic, the topics moved smoothly from one to the next and our students were engaged and a treat to be around. We owe a huge thank you to all of our speakers and students. Over the course of five days, participants heard from a diverse group of local experts on watershed management. Participants learned about the way creeks and rivers change over time while keeping their feet cool in the South Dry Sac River, about stormwater improvement projects in Springfield while walking around the Watershed Center and seeing demonstration storm water practices in place, and even poke their heads into a few demonstration septic treatment systems at the Onsite Wastewater Training Center. We are planning next year's academy and will post details in the springs, so stay tuned!
