# **Big Urbie Update**

### Stormwater Improvements and Planting Days at MSU and Drury

This summer, WCO and City Staff have been busy managing the construction of two detention basin retrofit projects on the Drury University and Missouri State University campuses to make water quality improvements as part of the Big Urbie grant. To "retrofit" a detention basin is to make changes to it that will improve the water quality in the system. In these cases, the concrete channels were removed and replaced with a meandering rock swale, and native vegetation will be planted along the rock swale in each basin to slow down and filter runoff, and allow it to soak into the ground. The general contractor Carson-Mitchell, Inc. did an outstanding job on these unique projects that required much attention to detail.

To finish the project, we will be planting at MSU on Wednesday September 3<sup>rd</sup> starting at 7:30 am and at Drury on Tuesday September 9<sup>th</sup> starting at 8:00 am. We have a lot of plants to get in the ground and could use some helping hands! This project was partially funded by The Springfield-Greene County Urban Watershed Stewardship Project (Big Urbie) water quality grant, with matching funds and in-kind assistance provided by the City and County. Big Urbie is a \$1.1 million federal grant awarded to Watershed Committee of the Ozarks by U.S. EPA Region 7 through the Missouri Department of Natural Resources under section 319 of the Clean Water Act in 2011. # **Busy Summer at the Watershed Center**

About 1500 students and adults have been involved in Watershed Center Field trips already this year! It has seemed extra busy because snow days pushed the school year late into May, and our spring field trips ran right into our summer camp season. We have developed a great partnership with the Ozarks Regional YMCA,

which brought over 330 summer day-campers to the Watershed Center. Each group got to explore the trails during scavenger hunts and create unique artwork based on natural objects found outside. Other local and regional schools came too, like the Republic elementary summer school who enjoyed nature hikes and hands-on experiences. These day camps and summer school groups were a new experience for me, but I had really good interns and volunteers to work with, and we had a lot of fun with them! (contd.)



# Busy Summer at the Watershed Center-Cont.

This year, the Valley Water Mill Equestrian Center and the Watershed Center developed educational partnerships. Each week throughout the summer, 6 to 10 students would take a hayride from the Valley Water Mill Equestrian Center to the Watershed Center and spend a couple of hours with staff and volunteers. Each student borrowed a backpack equipped with binoculars, magnifying glasses, bug nets, and more (backpacks donated by Bass Pro Shops) and we would set out together on the trail. Walking by sinkholes and springs, catching dragonflies and butterflies, and resting in the shade, we had the chance to tell these kids the story of how both the Watershed Center and the Equestrian Center protect our water resources.

The two parks are located on either side of the South Dry Sac river which, through underground karst features, feeds Fulbright Spring on the northwest side of town. This spring is a critical part of our drinking water supply and protecting the water in the streams that feed it allows us to protect the spring itself. With big, responsibly managed parks sheltering a section of the stream, we were able to help the kids make that connection.
