

## **Form Instructions:**

To receive the pump-out rebate, you must fill out the form at the time of pump-out and contact Watershed to confirm rebate funds are still available prior to pump-out. Rebates will not be granted to homeowners who have their tanks pumped prior to receiving approval from Watershed at 417-408-3310, or <u>Stacey@watershedcommittee.org</u>. Pumper must be from approved pumper list on page 4 to be eligible for the rebate.

Completed rebate form and copy of paid invoices must be received within 90 days of pump-out. This rebate can be issued to a landowner one time and is only available while grant funds remain. Pump-out rebates are funded by the United Sates Environmental Protection Agency through the Missouri Department of Natural Resources under the Section 319 of the Clean Water Act and delivered as a direct reimbursement (up to \$60) to landowners. Completed rebate form and paid invoices must be received within 90 days of pump-out. Please contact Project Manager Stacey at 417-408-3310, or Stacey@watershedcommittee.org with any questions.

If properly designed, constructed, and maintained, your septic system can provide longterm, effective treatment of household wastewater. Septic systems should be maintained regularly, based on the size and use of your tank. Pumping and regular maintenance of your system extends the life of your tank and lateral lines, protects against groundwater contamination, and reduces nutrient loading into nearby waterways - protecting drinking water. Don't let your septic system get to a point where it fails.

Routine maintenance is important to limit homeowner expenses and to help protect local water quality. Routine septic pump-outs (typically every 3 - 5 years depending on tank size and usage) will cost you around an average \$150-\$200 per pump-out. When a septic tank and lateral field reach a point of failure, it can be very costly to replace. Use our septic pump-out rebate program to help maintain your system.
